The following time allowance for an audit is included in the basic charge. Any time required to complete an audit in excess of the allowed time shall be charged for at a uniform hourly rate of \$118/hour.

Annual Dues: \$235 billed in January or July.

All fees are U.S. dollars.

An E-Services fee will be invoiced separately.

Digital edition audit hours (if applicable) are \$189/hour.

In addition to the fee above, media owner shall pay the "coach/economy" travel cost of the auditor to the actual location where the audit is made.

An additional charge of 50% of the regular auditing charge to provide for the travel time to the audit location is required. For publishing companies with multiple titles undergoing audits at the same time, this 50% surcharge shall be levied against only the highest audit charge.

Rates are subject to change by BPA's Board of Directors. The rates in effect at the time of the audit will be charged.
